

## It feels good to do good: The Florida Mission of Mercy

When we get involved in our associations, we are often asked to lend a hand to advocacy efforts and service to others. This past year our members helped each other through natural disasters, made foundation donations, participated in Dentists' Day on the Hill, and served those in need through the Florida Dental Association Mission of Mercy.

Did you know that when you give to others, whether that is through a gift of your time or a charitable donation, that you are boosting your own health? According to Mental Health America, "Research indicates that those who consistently help other people experience less depression, greater calm, fewer pains and better health. They may even live longer lives."

The Florida Mission of Mercy is a large-scale professional dental clinic that provides care to any patient at no cost to them, with the goal of serving the under-served and uninsured in Florida — those who would otherwise go without care. The 2023 Florida Mission of Mercy took place in West Palm Beach February 24-25 and included 2,086 volunteers, treating 1,327 patients with 9,543 procedures. The value of this care that is provided at no cost to the attendees was estimated at \$1.85 million.

And the value to the volunteers that gave their time to change lives? Well, priceless. Take a look at the photos of this year's event and you will see impact.

## A Systematic Approach to Comprehensive Treatment Planning for Aesthetics and Function

Gerard J. Lemongello Jr., DMD | 3 CEUs

Mastering treatment planning for aesthetics and function can be challenging. One of the most challenging areas for most dentists is the process of combining the aesthetic examination with the principles of the functional examination to create a treatment plan for success. This program is designed to simplify the entire process from examination through presentation. This program will provide a systematic, step-by-step approach to treatment planning. It integrates esthetics, occlusion, restoration, and periodontics into a logical format that provides confidence in developing the final treatment plan.

### **Learning Objectives**

- The four major areas that need to be considered in treatment planning.
- Facial esthetics and evaluation of how the face alters esthetic planning.

### **Advanced Case Planning and Treatment**

Cases to be presented will include: Full mouth case with and without change to vertical dimension; the Class II Division II crowded case; the severe wear case; the Class III case.

- Creation of the diagnostic wax up.
- All necessary stents, guides and matrices to aid in preserving or altering vertical dimension of occlusion.
- Preparation design for veneers, veneer onlays or full coverage crowns.
- Bite registration involving full mouth restoration including cross mounting provisional models and the custom incisal guide table.
- Fabrication of the provisional.
- Impression techniques.
- Final case insertion and management of occlusion.

## Implant Aesthetics: Diagnosis and Treatment Planning for Predictable, Functional and Esthetic Results

Mastering the art of predictable implant aesthetics can be challenging. In order to achieve lifelike, functional results, the clinician must first master the art of diagnosis and treatment planning. With the appropriate diagnosis and treatment plan, the next critical step is executing the treatment in a logical systematic way, managing expectation of the patient and achieving exceptional results. One of the most stressful areas for most dentists is the process of creating a beautiful provisional that will guide tissue and predictably achieve the aesthetic outcome for the final restoration in the aesthetic zone. Combining the use of a custom-fabricated provisional abutment, provisional restoration and a custom fabricated impression coping, many of the aesthetics challenges can be addressed. This program is designed to simplify and streamline the entire process of diagnosis, treatment planning, implant provisionalization and final restoration. This program will provide a systematic, step-by-step approach to mastering the critical skills in restoring implant cases. It integrates the techniques necessary in a logical format that provides confidence in developing the final restorative outcome.

## Safe and Effective Prescribing of Controlled Substances

Michael R. Ragan, DMD, JD, LLM | 2 CEUs

Oral-facial pain is real, and most dental personnel were taught that the most effective way to alleviate severe acute and chronic pain was with prescription opioids. As a result, most dentists prescribe them—with benefits but also unintended consequences for our patients. Opioids are also prescribed in emergency departments (EDs) to manage dental pain until treatment can be started. Regular use of opioids—whether prescribed by a health care provider or not —can lead to chemical dependence and, when misused, can lead to addiction, overdose, and death.

By making certain that every dental personnel who prescribes an opioid must have the training to decide when opioid medications should and should not be used. Dental professionals will then be more likely to achieve a balance between the benefits and risks of opioid prescribing, optimize patient attainment of therapeutic goals, and avoid the risk to patient outcome, public health, and viability of their own practice imposed by deficits in knowledge. This course provides the required information pertaining to CS/CS/HB 21, the law addresses opioid abuse by establishing prescribing limits, requiring continuing education on controlled substance prescribing, expanding required use of Florida's Prescription Drug Monitoring Program, EFORCSE, and more.

She credits the dental community and organized dentistry for enabling her to rebuild. "The FDA found me two weeks after Ian hit. They called me and said they had a grant for me."

Dr. Bouchard says that if it had not been for organized dentistry's assistance, she would've given up. "I was at the other end of my career. I asked myself, do I rebuild? It was the dental people who made it possible." West Coast District Dental Association President Dr. Rita Hurst organized WCDDA's efforts to help Dr. Bouchard and other dentists affected by Ian. WCDDA member, Dr. Jose Alvarez was one of the first WCDDA members who stepped up: "He reached out to me and offered to let me use his office on Fridays," says Dr. Bouchard. "One month after Ian, we were seeing patients."

Dr. Bouchard heard from other WCCDA members, too. Dr. John Park of Winter Haven called her soon after the hurricane. "I was your student at Boston University Dental School," he told her. "What can I do for you?" Soon after that, Dr. Andrew Frey of Fort Myers offered his office space to Dr. Bouchard when he moved to a new location.

"I can't believe the generosity of people," says Dr. Bouchard, "Dentists are amazing." She shared more words of thanks in a letter she sent to WCDDA headquarters. "Ian has taught me a lot," she wrote. "The biggest lesson? Receiving the kindness of others..."

## Words of Appreciation for Help after Hurricane Ian



very much for being a big part of the resilience of a little dental practice on a little island."

After experiencing the devastation of Hurricane Ian, Dr. Bouchard suggests that dentists prepare now for potential disasters by reaching out to the FDA, "The FDA has everything you need to do. My team followed those procedures, but nothing could've prepared us for Ian."

Now, along with caring for her patients and her team, Dr. Bouchard is also intent on sharing her appreciation with those who came to her aid. At the recent WCDDA Annual Meeting in February, Dr. Bouchard made a point of finding former FDA president Dr. Rudy Liddell, "I thanked Rudy and told him that if it wasn't for that call from the FDA, the rebuilding of my practice wouldn't have happened."

And what about making the time to write that thank you note to the WCDDA even in the midst of trying to rebuild her practice? "How do I not thank these people?" she says. "I wouldn't be here without them."

## ADA Answers Your Questions on New DEA Registration Requirement Effective June 27

In December 2022, the U.S. Congress passed an omnibus spending bill that included the Medication Access and Training Expansion (MATE) Act. This new law requires prescribers of controlled substances, including dentists, to complete eight hours of one-time training on safely prescribing controlled substances (Schedules II, III, IV, and/or V) in order to receive or renew their registration with the U.S. Drug Enforcement Administration (DEA). It's likely that you received an email from the DEA last week notifying you of this new requirement, which goes into effect on June 27, 2023.

To help dentists comply, the ADA has created Frequently Asked Questions document addressing common questions and will update the FAQ regularly to answer new questions and share additional information. Scan the



## "DIY" Dentistry Poses Risks for Floridians



From YouTube videos to ads on do-it-yourself (DIY) at-home teeth straightening and whitening, DIY dentistry is a growing trend. However, DIY dentistry can cause serious and sometimes irreparable damage.

#### **Dentists Are Educated for a Reason**

Dentists have the extensive education and training to understand how your teeth and mouth are impacted by dental treatments. Orthodontists undergo even more training to know the mechanics of how bones, teeth and gums move and grow in order to safely and effectively straighten teeth.

Patients who undergo dental treatment without first seeing a dentist won't know if they have underlying problems, such as tooth decay or gum disease, that can be made worse by unsupervised treatment.

As Florida's advocate for oral health, the Florida Dental Association (FDA), along with the American Dental Association (ADA), works to educate Floridians on the risks of undergoing dental treatment without the expert care of a dentist or specialist. The ADA strongly discourages the practice of direct to consumer dental laboratory services because of the potential for irreversible harm to patients. This includes services where patients take their own impressions and order products such as teeth bleaching products, partial dentures, veneers and aligners.

DIY dental treatments have the potential to cause damage and irreversible complications for patients.

- Jaw problems
- Bite problems
- Gum disease
- Infection

## HOW PATIENTS CAN REPORT A PROBLEM

If a patient experiences any problems with direct to consumer (DTC) dental laboratory products, such as aligners or partial dentures, they can report them to the U.S. Food and Drug Administration at <a href="https://www.fda.gov/safety/medical-product-safety-information/forms-reporting-fda">www.fda.gov/safety/medical-product-safety-information/forms-reporting-fda</a>.

Specifically, Form FDA 3500B – Voluntary Reporting for Consumers (a consumer-friendly reporting form).
